As a leading expert in the field, he also assisted policymakers in developing key legislation, including the Digital Economy Act (2018). On behalf of the CESSDA community, I would like to congratulate Matthew

Woollard on this honour and thank him for his crucial role during the early years of CESSDA ERIC and important transition periods. CESSDA is very proud and honoured to have such a leader in the field of data services.

Finally, CESSDA, GESIS, the German Data Archive, and LiDA, the Lithuanian Data archive were invited to a panel discussion at the WAPOR 77 conference in Seoul, Korea. This was also a great opportunity to connect to KOSSDA, the Korean Data Archive.

## First results of the OSCARS Open Call have been published

The first OSCARS Open Call, launched to foster cutting-edge research and services across a wide range of scientific disciplines, received an overwhelming 264 proposals from 33 countries. The call

resulted in the selection of <u>58 innovative projects</u>, reflecting a significant step forward for open science in Europe.

The proposals encompassed diverse fields, from astronomy and particle physics to environmental sciences, life sciences, photon and neutron science,

and the social sciences and humanities. As a core partner representing the social sciences, CESSDA is particularly pleased to see robust participation

from the social sciences community and the interdisciplinary nature of many of the selected projects.

These selected projects are spread across 19 countries and include not only academic and research institutions but also small and medium-sized enterprises (SMEs), non-profit organisations, and even a large company. As a project partner CESSDA brings its experience in promoting open data and FAIR principles in the social sciences, therefore we view this successful call as both a major milestone for the OSCARS project and the European open science movement. The projects selected will contribute to making scientific data, software, and tools more accessible, facilitating better research collaboration, data sharing, and reuse.

CESSDA ERIC, GESIS, the German Data archive, and LiDA (the Lithuanian Data Archive) were invited to discuss in a featured panel with colleagues and

partners from Korea, Hongkong and the US at the 77th World Association for Public Opinion Research (WAPOR) annual conference on July 28-31, 2024 in Seoul, Republic of Korea.

The conference `The soul of public opinion research: Liberty, Quality and Humanity´ discussed the latest developments in public opinion research, misinformation, and the study of campaigning and voting behavior. The focus was on challenges and opportunities posed by internet technologies such as social media platforms, artificial intelligence or quantum computing. In this context the important role of data archives was highlighted in a panel discussion on `Long-term memory: a prerequisite for survival - how archiving elevates the social science of opinion research and ensures its enduring positive impact on society.

WAPOR 2024 was hosted by the Sungkyunkwan University, which was founded in 1398 as the highest national educational institute in the early years of the Joseon Dynasty in Korea, and is the oldest university in East Asia.

Co-organisers were: the National Research Council for Economics, Humanities, and Social Sciences, the Korean Sociological Association, the Korea Social Science Data Archive (KOSSDA), the Korean Association of Party Studies, the Korean Association for Survey Research, and the Institute of Social Development and Policy Research at Seoul National University.

The 4-days conference gathered over 400 researchers from 51 countries with about 270 presentations organized in 60 conference sessions and 8 training workshops.

### A new and improved data repository for PROGEDO

In June 2024, <u>PROGEDO</u> implemented a major upgrade to its data repository, <u>Quetelet-Progedo-Diffusion</u>, streamlining data access. A new interface has been set up—backed by a help desk and ticketing



software, <u>Zammad</u> — making it now possible for users to discover, identify and request data of interest all through a single entry point. The requested data are then made available to users via a secure file sharing space based on <u>Nextcloud</u>.

#### SND receives extended grant from the Swedish Research Council until 2028

SND is one of the 19 research

infrastructures that the Swedish Research Council gives top priority in their decision on which infrastructures can apply for grants for continued funding. The decision also states that SND's current grant period is extended by two years until 2028. During the extended period, an investigation will be conducted to clarify SND's role and responsibilities.


